PTPTN Loan Online Application - Guideline For Students

PURCHASE BSN PIN NO. FROM BSN BANK
(Students purchase PTPTN pin no. from BSN Bank /IUMW Loan Dept assist to purchase)

STUDENTS FILL UP ONLINE APPLICATION FORM
(Students have to fill up PTPTN Online Application Form with full information required)

STUDENTS SUBMIT THE ONLINE APPLICATION FORM
(Students have to submit the PTPTN Online Application with full information required)

IUMW ASSIST TO APPLY ONLINE
(Students are encouraged to apply online by their own with guidance from IUMW Loan Officer)

ON COMPLETION OF ONLINE, STUDENTS FILL UP THE FOLLOWING DOCUMENTS:
1) ONLINE APPLICATION
2) PTPTN FEE SCHEME

CONFIRM ONLINE APPLICATION
(Students must get verification from IUMW Loan Officer before sending the Online Application)

- * In the event of non-submission of application, IUMW will convert the loan payment mode to Cash payment mode, 30days after the commencement of Programme.
- ** Please be informed, total loan is depending on your BR1M holder.

PTPTN CLOSING DATE

The approval of application will be announced within 7 days after the closing date of each submission - I.e. (via SMS from PTPTN Malaysia)

Closing date: 1st - Feb (28 Feb - 30 March)
Degree Intake 2nd - June (30 June - 30 July)
3rd - Sept (30 Sept - 30 Oct)

NOTIFY DATE AND VENUE

Students have to submit the Loan Agreement, within 1-3 days of approval from PTPTN Malaysia. IUMW Loan Dept to notify the venue, date and time for submission of the Loan Agreement.

PRINTING OF THE LOAN AGREEMENT

Students will be guided on how to print the Loan Agreement (refer to PTPTN notice board) and sign the agreement on the required pages.

SUPPORTING DOCUMENT REQUIRED

1) IUMW Offer Letter -1 copy

DUTY STAMP AND SUBMISSION

Students must pay RM20 / - with cash for duty stamp MAYBANK acc. and direct debit to IUMW account when submitting the PTPTN application form

PAYMENT AND RECEIPT

PTPTN Malaysia makes payment to the students MAYBANK acc. and direct debit to IUMW account for the tuition fee, Receipt can be collected from the finance counter within 2 weeks after the payment being entered into the students account.
